Getting Started - Opening your account

Step by step Guide:

- Open a Guest Membership Account with World Cup Advisor here: [FREE MEMBERSHIP](#)
- Establish your trading account through GFF Brokers by completing this application link: [GET STARTED](#) If you encounter any issues please contact newaccounts@gffbrokers.com
- You will be contacted by GFF Brokers New Accounts Department once your application has been reviewed. This is typically done within one business day.
- GFF Brokers will then let you know of any additional documents (i.e., copy of government-issued photo ID, utility bill, etc.) that may be needed to proceed with your application approval.
- In the email, GFF Brokers will also send you the Letter(s) of Direction to complete for the programs you would like to follow (Prophetick and/or Radium)
*Please see additional Letter of Direction information below.
- Once your account(s) are open, you can expect a detailed email from GFF Brokers New Accounts Department, which will include funding instructions.
- Once you have received your trading account number(s) and are ready to fund your account, confirm with GFF Brokers the programs and number of units you would like to follow.

Getting Started

Completing Additional Documents – Letters of Direction

The following is the suggestion made based solely on the minimum funding requirements for each program.

It should not be considered personal financial advice.

Completing Letter(s) of Direction and Additional Account Authorizations – You will provide these documents during the account opening process.

- If your account funding is **less than \$30,000 USD** provide
 - 1) Letter of Direction for **Comhla-Prophetick**
 - fill in page 3 - #13 – add your account number
 - #14 - \$100/Comhla-Prophetick
 - 2) Additional Account Authorization
 - purpose is “World Cup Advisor – Comhla-Prophetick”
 - leave the “New account number” field blank

- If your account funding is **greater than \$30,000 but less than \$37,500 USD** provide
 - 1) Letter of Direction for **Comhla-Radium**
 - fill in page 3 - #13 – add your account number
 - #14 - \$300/Comhla-Radium
 - 2) Additional Account Authorization
 - purpose is “World Cup Advisor – Comhla-Radium”
 - leave the “New account number” field blank

- If your account funding is **greater than \$37,500 USD** provide BOTH

1) Letter of Direction for **Comhla-Radium**

- fill in page 3 - #13 – add your account number
- #14 - \$300/Comhla-Radium

2) Additional Account Authorization

- purpose is “World Cup Advisor – Comhla-Radium”
- leave the “New account number” field blank

3) Letter of Direction for **Comhla-Prophetick**

- fill in page 3 - #13 – add your account number
- #14 - \$100/Comhla-Prophetick

4) Additional Account Authorization

- purpose is “World Cup Advisor – Comhla-Prophetick”
- leave the “New account number” field blank

Getting Started – what happens next?

Once your account is opened and funded, and you have confirmed instructions to start, you will be placed in the allocation block for trading to begin.

For example:

You open a Prophetick unit account for one unit.

If Prophetick is in a trade, you will automatically be placed in the trade. It will not wait until the next trade.

***This may create a different fill price than John’s lead Comhla account for the initial trade. It may also alter whether it is a winning or losing trade compared to Comhla.



Getting Started – Special Discounts for Comhla

DISCOUNTS AVAILABLE FOR YOUR INITIAL MEMBERSHIP UNITS

- Any units signed up for PRIOR TO JUNE 15 are eligible for a **20%** discount FOR LIFE
- Any units signed up for BETWEEN JUNE 16 and JULY 21 are eligible for a **10%** discount FOR LIFE
- No – you cannot combine them.
- In addition – accounts under \$10,000 will not be charged the WCA monthly membership fee of \$20

It adds up!

Discount Example:

- Get your account open with \$40,000 USD
- Subscribe to 1 Radium Unit (\$300/month) and 1 Prophetick Unit (\$100/month)
- Regular price: \$400
- Your Price: \$320
- Your \$80 per month discount will continue for the life of your account
